### **Douglas H. Kay Distinguished Pharmacy Educator Award**

*Sponsored by: Maine Pharmacy Association*

The Douglas H. Kay Distinguished Pharmacy Educator Award is named after Maine's "most distinguished" and nationally recognized pharmacy educator. The Award recognizes those who have made a significant contribution to pharmacy education in Maine and who have had a positive influence in the lives of future generations of pharmacists in the state. Nominees must have shown a commitment to the overall mission and objectives of pharmacy education with at least 15-years' experience in any type of pharmacy education, including teaching, precepting and mentoring of trainees.

### **Bowl of Hygeia Award**

The Bowl of Hygeia Award recognizes pharmacists who possess outstanding records of civic leadership in their communities and encourages pharmacists to take active roles in the affairs of their respective communities. The award is presented annually by participating state pharmacist associations, including those in the District of Columbia and Puerto Rico. In addition to service through their local, state and national pharmacy associations, award recipients have devoted their time, talent and resources to a wide variety of causes and community service.

### **Upsher-Smith Excellence in Innovation Award**

The NASPA Excellence in Innovation Award recognizes and honors a qualified pharmacist who has demonstrated significant innovation in his or her respective practice, method, or service directly or indirectly resulting in improved patient care and/or advancement of the profession of pharmacy.
